## **REQUIREMENTS FOR A MALVERNE ELECTRICAL LICENSE**

<u>Please note the following:</u>

- \*\*\*Going forward all licenses and permits will be issued via email. Please be sure to provide a valid email address on your application for all correspondence.
- \*\*\*No work can begin until a permit is issued. Please submit applications and proper fees in a timely fashion.

The following information must be submitted to the Building Department (**PARTIAL INFORMATION WILL NOT BE ACCEPTED**):

- 1. Application form (see enclosed)
- 2. Certificate of liability insurance with the Inc. Village of Malverne listed as a certificate holder and additional insured. Liability insurance limits in the amount of \$2,000,000 General Aggregate / \$1,000,000 single limit bodily injury and property damage.
- 3. Additional insured endorsement form CG2012 or its equivalent for State or Governmental Agency or Subdivision or Political Subdivision – Permits or Authorizations (sample enclosed). IMPORTANT NOTICE TO INSURANCE BROKER/AGENT: The Incorporated Village of Malverne must be an additional insured with a CG 20 12 or CG 20 26 additional insured endorsement or an appropriate blanket additional insured endorsement or ISO CG 2012 equivalent. The additional insured endorsement must reflect the Village's role as a governmental entity issuing a permit. This excludes the CG 20 09, CG 20 10 and CG 20 33 forms, because the permit applicant isn't performing any work for the Village
- 4. Copy of the declaration page from your liability policy showing the business description or classification.
- 5. Certificate of disability benefits insurance coverage with the Inc. Village of Malverne listed as the certificate holder. If you employ no help then you must submit a waiver (CE-200) from the NYS Workers Compensation Board at time of licensing and any time a permit application is submitted.
- 6. Certificate of workers compensation insurance coverage with the Inc. Village of Malverne listed as the certificate holder. If you employ no help then you must submit a waiver (CE-200) from the NYS Workers Compensation Board at time of licensing and any time a permit application is submitted.

## \*\*\* Acord forms will NOT be accepted as proof of workers compensation or disability insurance\*\*\*

- 7. Copy of your current Town of Hempstead, North Hempstead or Oyster Bay Master Electrician's license. Receipts/registration cards will <u>NOT</u> be accepted.
- 8. Copy of your Certificate of Competency from the Township where you originally took your test (Town of Hempstead, North Hempstead, or Oyster Bay only).
- 9. Check or money order in the amount of 250.00 made payable to the Inc. Village of Malverne; license in force from 1/1/2024 12/31/2025.
